GENERAL TERMS & CONDITIONS

2. The competition is open to UK residents only (excluding residents of the Channel Islands and Isle of Man). Employees of Hampshire County Council, Mill Rythe, Away Resorts and Spinnaker Tower as well as their immediate families are not eligible to enter the competition. Entrants must be over the age of 18 to enter.
3. Entrants must provide their name and email address if selected at random as the winner. They must agree to the general terms and conditions and privacy policy.
4. Visit Hampshire will only ever use personal details for the purposes of administering the competition. Visit Hampshire will only keep your personal details for as long as is necessary to fulfil these purposes. Visit Hampshire will not pass on your personal information to a third party without your prior permission. Visit Hampshire abide by the General Data Protection Regulation of 2018 and complies with its provisions to ensure that any data you provide is treated accordingly.

The competition closes at 23:59 on 1 September 2024. Entries received after this date will not be considered. The prize consists of:

- 4-night stay at Mill Rythe Coastal Village, Hayling Island.
 - Specific terms and conditions: Maximum prize value of £500. Prize must be booked by an adult, over the age of 18. Off-peak periods only. Travel, meals, and additional activities are not included. Maximum six people. Guest passes for facilities and entertainment will be included for each member of the booking. Pet friendly and hot tub options available upon request. If the holiday is cancelled less than two weeks prior to the arrival date, then it will not be rescheduled, and the prize will be lost. - A family ticket to Staunton Country Park.
 - Valid until 31st December 2024 for either 2 adults and 2 children or 1 adult and 3 children.
