GENERAL TERMS & CONDITIONS

1. The title for this competition is “Win four tickets to the Hawk Conservancy Trust”
2. The competition is open to UK residents only (excluding residents of the Channel Islands and Isle of Man). Employees of The Marketing Collective, Hampshire County Council and the Hawk Conservancy Trust as well as their immediate families are not eligible to enter the competition. Entrants must be over the age of 18 to enter.
3. Entrants must provide their name and email address if selected at random as the winner. They must agree to the general terms and conditions and privacy policy.
4. Visit Hampshire will only ever use personal details for the purposes of administering the competition. Visit Hampshire will only keep your personal details for as long as is necessary to fulfil these purposes. Visit Hampshire will not pass on your personal information to a third party without your prior permission. Visit Hampshire abide by the General Data Protection Regulation of 2018 and complies with its provisions to ensure that any data you provide is treated accordingly.

The competition closes at 23:59 on 2 August 2026. Entries received after this date will not be considered. There are four prizes available, consisting of:

- 4 x Full-day tickets to the Hawk Conservancy Trust (Adult £23.50 / Children (4 - 15yrs) £17.65 / Student £21.50/ Senior 60+yrs £22.45)
5. Prize tickets may be for all adult or adult/child groups but children must be accompanied by at least one adult.
 6. One competition entry per person.
 7. The judges' decisions will be final, and no correspondence can be entered into.
 8. Visit Hampshire reserves the right to cancel this competition or alter any of the rules at any stage, if deemed necessary in its opinion, and if circumstances arise outside of its control.
 9. The prize excludes: any form of insurance, travel to and from the attractions, any personal expenses and spending money, any additional events or experiences.
